Minneapolis Neighborhood and Community Relations Department's Community Participation Program (NCR): This contract provides funding to engage residents and other stakeholders in the work of the community and provided support for: the continuing engagement with the East Downtown Council (EDC) in order to grow the leadership and participation of the district-wide business community; connecting the nonprofit leaders in order to build stronger relationships for potential collaborative activities through the efforts of the Elliot Park Leadership Group (EPLG); serving as the fiscal agent and facilitating the planning and development of the annual community Night to Unite celebration, a collaborative effort sponsored by a number of neighborhood institutions and nonprofit organizations; maintaining involvement with the Downtown

4b (Code:) (Expenses \$ 51,319. including grants of \$) (Revenue \$ 54,202.) Neighborhood Revitalization Program (NRP): All Elliot Park Neighborhood, Inc. (EPNI) projects and programs have seeds in the Elliot Park Neighborhood Master Plan. The Building, Land Use, and Housing Committee (BLUH) continued its work bringing the community together to review concerns and to make decisions about issues that directly affected them. This process often included opportunities to bring city and county staff into the neighborhood to participate in this discussion. The Livability Task Force continued to focus more closely on crime, safety, and property issues of concern to the neighborhood and experienced increased participation and leadership from neighborhood institutions. Staff served on the Downtown Council's 2025 Development Committee which collaborated on shared goals;

4c (Code:) (Expenses \$ 35,672. including grants of \$) (Revenue \$) McKnight Foundation Grant: Work continued with support from the McKnight Foundation. The general operating support awarded continues to advance the goals of the Elliot Park Master Plan. As the Viking's stadium issue remained in the forefront, the attention it commanded from varying stakeholders afforded a growing opportunity for EPNI to advance its goal and to forge new relationships and collaborations.
