4b (Code: ) (Expenses \$ 40,604. including grants of \$ ) (Revenue \$ 40,689.) Neighborhood Revitalization Program (NRP): All EPNI projects and programs have seeds in the Elliot Park Neighborhood Master Plan. The BLUH Committee continued its work bringing the community together to review concerns and to make decisions about issues that directly affected them. This process often included opportunities to bring city and county staff into the neighborhood to participate in the discussion. The Livability Task Force continued to focus more closely on crime, safety and property issues of concern to the neighborhood and experienced increased participation and leadership from neighborhood institutions. Staff served on the East Downtown Business Partnership Downtown board and various committees and task forces working on issues related to community revitalization.

4c (Code: ) (Expenses \$ 18,413. including grants of \$ ) (Revenue \$ ) McKnight Foundation Grant: Work continued with support from the McKnight Foundation. The general operating support advances the overall goals of the Elliot Park Master Plan that was developed and adopted by the community in 2003. EPNI continues its work developing and strengthening district-wide relationships in order to bring resources to the community.
