4b (Code:) (Expenses \$ 69,994. including grants of \$) (Revenue \$ 67,886.) Neighborhood Revitalization Program (NRP): All Elliot Park Neighborhood, Inc. (EPNI) projects and programs have seeds in the Elliot Park Neighborhood Master Plan. The Building, Land Use, and Housing Committee (BLUH) continued its work bringing the community together to review concerns and to make decisions about issues that directly affected them. This process often included opportunities to bring city and county staff into the neighborhood to participate in this discussion. The Livability Task Force continued to focus more closely on crime, safety, and property issues of concern to the neighborhood and experienced increased participation and leadership from neighborhood institutions. Staff served on the Downtown Council's 2025 Development Committee which collaborated on shared goals;

4c (Code:) (Expenses \$ 81,520. including grants of \$) (Revenue \$) McKnight Foundation Grant: Work continued with support from the McKnight Foundation. The general operating support awarded continues to advance the goals of the Elliot Park Master Plan. As the Viking's stadium issue remained in the forefront, the attention it commanded from varying stakeholders afforded a growing opportunity for EPNI to advance its goal and to forge new relationships and collaborations.
