The agenda was approved as presented.

The January 2017 meeting minutes were approved as presented. M. Winkel/Lazaretti.

### **Downtown Service Area Master Plan**

Tyler Pederson presented the Downtown Service Area plans focusing on the Elliot Park Neighborhood. Public comments are being received through March 4<sup>th</sup>. This year we will start to see ADA upgrades throughout the park system. Last year the City of Minneapolis approved a twenty-year funding plan for MPRB which increases former funding (approximately 3-4 million) to \$11 million annually.

## **I-94 Resurfacing Project**

Marcel Walker and Dave Aeikens, MnDot, presented plans for the I-94 resurfacing project. It is a two-year project beginning in March. There will be a significant impact to area traffic as the Lowry Tunnel undergoes lane reductions for three months, May-August. Ramp closures and reduced lanes cannot be avoided and MnDot is encouraging commuters to use alternate routes and public transportation. ## 7<sup>th</sup> Street Pedestrian Crossing

Tilahun Hailu and Allan Klugman, Mpls. Public Works, presented the pedestrian/traffic analysis that was conducted on December 7, 2016. While 9<sup>th</sup> Street demonstrated more problems, overall the numbers did not warrant a traffic signal at 9<sup>th</sup> or 10<sup>th</sup> Street. Coincidentally public works will be adding curb bump-outs to the four corners at 9<sup>th</sup> and at 10<sup>th</sup> Street in 2018 which will reduce the crossing distance at those corners and reduce crossing time. They will be discussing the analysis report within their department for further review and suggestions and return to the community again with an updated report. The neighborhood requested that they provide a cost estimate for other solutions, i.e. flashing lights as it was suggested that some options might be installed if community/business dollars paid for it.

# HCMC Pocket Park Sign at Park Avenue & 9th Street

Nick Balagurchk presented the updated monument sign design that conforms to the city sign guidelines. Previously the community requested and approved a pole sign design but it was then determined to not conform to standards. The sign is a smaller monument sign than the other three located on the other clinic corners and of a different design. It will face 9<sup>th</sup> Street at the corner of Park Avenue and will not be illuminated.

Motion to approve the HCMC Clinic monument sign for the pocket park at the corner of 9<sup>th</sup> Street and Park Avenue as presented on February 16, 2017. M. Lazaretti/L.Merrill. Passed

### **US Bank Stadium Fence**

The Minnesota Vikings plan to build a semi-permanent fence around the stadium. It does not require city approval as long as it is on the stadium property and under 8-feet tall. Fencing on the west side of the stadium will only be installed during the football season. The fence design will match the iron fencing that is currently along the perimeter of the team parking lot on the southeast corner of the property. The Vikings will be presenting their fence plan to the Downtown Minneapolis Neighborhood Association at their regular board meeting on February 27<sup>th</sup>, 6 pm at Open Book. EPNI has also invited them to attend the March 16<sup>th</sup> BLUH meeting.
